Dear Mr. VanZandt:-

Our Committee on New Location requested that the Board meeting last Saturday be postponed because they were not quite ready to make a report. Two propositions have been considered; one is to take the Monypeny Building at the corner of Spruce and High which Mr. Monypeny agrees to remodel according to our plans and lease to us for the term of ten years at \$350 per month including heat. The other proposition is to take the Northern Hotel at the corner of Goodale and High Sts. This would give us over twice the space of the Monypeny Building. The lease would be for ten years at \$375 per month. This does not include heat but includes furnishings. The owners of the hotel property have a mortgage on the furniture of \$7600. This hotel was refurnished five years ago at a cost of \$14000. This \$375 per month not only pays the rent but in the ten years purchases outright the furnishings, for everything in the way of equipment will then belong to us. The propositions boil down to this; Monypeny Building \$350 per month including heat but not including furnishings; Northern Hotel property \$375 per month not including heat but including furnishings.

The Committee would like to submit to the Board next Friday evening at 7:30 its report. This is possibly the most important Board meeting we have ever held and we sincerely hope every member of the Board will be present. Hoping you will be at the Terminal Department Friday evening at 7:30 to help decide the matter of a future home for our Association I remain
